Scope of Reporting for ESG Structured Data and Disclaimers

Siam City Cement Public Company Limited (henceforth "the Company") has prepared the ESG Structured Data report, which details the Company's performance on sustainable development, with the scope of reporting as follows:

Environmental Data

This category includes data on environmental management and performance of environmental-related operations of the cement business segment, which consists of Siam City Cement Public Company Limited, a domestic subsidiary Siam City Power Company Limited, and overseas subsidiaries including Siam City Cement (Vietnam) Company Limited, Siam City Cement (Bangladesh) Company Limited, and Siam City Cement (Lanka) Company Limited.

Environmental data includes data from activities that the Company has deemed to potentially have significant environmental impacts, and are activities related to the production processes. Activities that may not have significant environmental impacts such as the operation of sales offices, laboratories, or service provisions, are not considered. This deliberation has been made in accordance with the ESG risks estimation by related parties.

The report on sustainable development index for cement business / sustainable development report has been prepared in accordance with the Global Cement and Concrete Association (GCCA), with units used in the reports adjusted as would be appropriate per the requirements of the Stock Exchange of Thailand's reporting platform.

Data reported under the energy management and water management categories includes data from the operation of the Company's headquarters, the cement production plants in Saraburi province, and the cement production plants outside of Thailand operated by the overseas subsidiaries.

Data reported under waste management includes data from the operation of the Company's headquarters and the cement production plants outside of Thailand operated by the overseas subsidiaries managed in accordance with the agreements on hazardous and non-hazardous waste of the countries these subsidiaries operate in. Data from the cement production plants in Thailand, however, is not available this year, as this report was produced before the Company's reporting cycle. The Company shall optimize its reporting cycle to alleviate this issue moving forward.

Data reported under greenhouse gas (GHG) emissions includes the following:

- 1) Target for direct GHG emissions (Direct Scope 1), which includes the emissions by Chip Mong Insee Corporation
- 2) Actual GHG emissions both direct (Direct Scope 1) and indirect (Direct Scope 1), <u>not</u> including the emissions by Chip Mong Insee Corporation

Calculations of actual GHG emissions both direct and indirect consider only the emissions of CO₂, calculated in and displayed as CO₂ equivalent.

Social Data

This category includes data on Social management and performance of social-related operations by the Company and the subsidiaries, which include Siam City Cement Public Company Limited, domestic subsidiaries including Siam City Concrete Company Limited, INSEE SUPERBLOCK Company Limited, INSEE Ecocycle Company Limited, INSEE Digital Company Limited, Siam City Power Company Limited, Conwood Company Limited, and Siam City Cement Trading Company Limited, and overseas subsidiaries including PT Conwood Indonesia Company Limited, Siam City Cement (Vietnam) Company Limited, Siam City Cement (Bangladesh) Company Limited, and Siam City Cement (Lanka) Company Limited.

"Employees" is defined as contracted, permanent employees, including operational level employees, management level employees, and high-level executives. The scope of the report in the statistics of the Company's employees is as detailed below.

Data on employee development considers the hours and expenses relating to employee training, and considers the operations of all companies within the Group as listed in an earlier paragraph.

"Remunerations" is defined as the salaries paid to employees, and other remunerations paid by the Company in addition to salaries as incentives, including overtime payments and other benefits, and considers the operations of all companies within the Group as listed in an earlier paragraph.

The data on health, safety, and work environment covers the operations of all companies within the Group as listed in an earlier paragraph. This data includes all cases of injuries from work that result in at least 1 day of sick leave, as per the Stock Exchange of Thailand

Governance Data

This category includes data on governance, and the performance results of governance-related operations. The data considers only the operation of Siam City Cement Public Company Limited, as specified by the provided questionnaire, and does not cover the operations of the subsidiaries.

Disclaimer

This report was prepared for the purpose of disclosing information on the Group's effort on sustainable business development, and covers the Group's operations, structure, and performance relating to this matter. The information therein encompasses categories including data on environment, society, and governance. The disclosure was tailored to suit the Stock Exchange of Thailand's platform. Some differences in details exist in certain categories of data between the data available and the data required by the Stock Exchange of Thailand; remarks are available on all parts where such differences exist to clarify the issue as the platform would allow them.
